# 2018-2019 BUDGET AMENDMETNS AND TRANSFERS

A motion was made by Director Przybyla, seconded by Director Budnick, to approve the FY2018/2019 budget amendments and transfers as presented.

### VISITOR INFORMATION AREA

City Mgr. Hefele reported that the City received 12 signs from NOAA that are part of Great Lakes Maritime Heritage Trail; they will be installed at the Marina. Hefele explained the proposal was to install the two larger signs from NOAA, that are a kiosk style sign, in the area south of the Marina parking lot next to the current visitor information center. Also proposed, was replacing the information center with one or more units that are user-friendly. Discussion was had on the information center, how many are needed, cement pad that will make the area ADA assessable and where the NOAA signs and information center should be located.

## **DDA RESOLUTION NO. 2019-15**

A motion was made by Director Przybyla, seconded by Director Nadolsky, to approve the purchase of one of the information center's as proposed at a cost of \$1,018.

## **SAILOR'S MEMORIAL**

City Mgr. Hefele reviewed the plan to update the Sailor's Memorial, which he hopes will be completed prior to the Nautical Festival. Hefele is requesting the DDA to front the project until the funds can be raised. He explained that the project will not start until all costs are known and if the cost exceeds \$6,000 he will come back to the DDA.

### DDA RESOLUTION NO. 2019-16

A motion was made by Director Przybyla, seconded by Director Nadolsky, that the DDA will front the Sailor's Memorial project as presented until the funds can be raised with a cost of up to \$6,000. Ayes – All, the motion carried.

#### **OTHER BUSINESS**

- •Avenue of Flags City Mgr. Hefele will be placing an article in the *Presque Isle County Advance* asking for community input on ideas for flags that will be flown in the Avenue of Flags.
- •Third and Erie four way stop Need signage stating that pedestrians have the right-of-way.
- •Mariner's Mall City Mgr. Hefele stated that the Third Street side of the Mariner's Mall was damaged and all the brick will have to be replaced; this is an opportunity to speak with the owner about promoting the City and/or Marina on their building.
- •Third & Erie Chr. Budnik stated that some of the plants need to be replaced.

### **DDA RESOLUTION NO. 2019-17**

A motion was made by Director McLennan, seconded by Director Gajewski, to approve the purchase of plants for the Third and Erie corner; cost not to exceed \$200.
